



INVITATION TO TENDER

1. BACKGROUND

The Botswana Public Officers' Medical Aid Scheme (BPOMAS or "the Scheme") was established through Presidential Directive CAB 1/90 on 01 December 1990 and is registered in terms of the Societies Act, with the specific intent to provide medical aid cover for public servants and their dependents. BPOMAS also extends cover to Cabinet Ministers, Members of Parliament, Members of the House of Chiefs and Parastatals.

2. REQUIREMENTS OF THE BIDDING DOCUMENT

- 2.1** BPOMAS aims to enhance access to dental health support for its members. To achieve this, the Scheme invites proposals from licensed and suitably qualified local and international service providers to bid for the Provision of Dental Health Risk Management Services.
- 2.2** Bidders must be duly registered with Companies and Intellectual Property Authority (CIPA) or equivalent authority in the country of origin, the latter being for a company domiciled or registered in a foreign jurisdiction.

Each Bidder shall submit only one Bid, either individually or as a partner in a joint venture or consortium.
